<b>Supervision/ Mentorship</b>	<ul style="list-style-type: none"> <li>0.5 PAC for a minimum of 25 hours of direct clinical / non-clinical student supervision at a site used by an ACGC-accredited program.</li> <li>0.1 PAC for at least 10 hours per year for providing direct professional supervision / coaching / mentoring, including participating in a process group or peer supervision. Activities / service must be related to a practice-based competency for genetic counselors.</li> <li>Max 1 PAC per year</li> </ul>	For all supervision / mentorship, list mentee's name, training program (if applicable), supervision dates and number of supervision hours. Activities / service must be related to a practice-based competency for genetic counselors.
<b>Research</b>	<ul style="list-style-type: none"> <li>1 PAC if first, second or senior author of an article or chapter in peer-reviewed journal or book; 0.5 PAC for any other author that is not first, second or senior. Publication must be related to a practice-based competency for genetic counselors.</li> <li>0.1 PAC for serving on an IRB / REB for at least 10 hours per year.</li> <li>0.5 PAC per student for serving as a primary advisor on a student research project committee, OR 0.1 PAC for serving as a student research project committee member.</li> <li>0.2 PAC for presenting a peer-reviewed poster / performing a platform presentation at a conference OR 0.1 PAC for non-presenting author on a peer-reviewed poster / platform presentation at a conference.</li> <li>0.2 PAC per manuscript reviewed by invitation for a scientific journal.</li> <li>Max 1 PAC per year</li> </ul>	List activity involvement, dates and hours associated to activity.
<b>Leadership Activities/ Professional Service</b>	<ul style="list-style-type: none"> <li>0.5 PAC per 25 hours of service in a leadership role such as, but not limited to, a board member, committee / taskforce chair / co-chair, or Special Interest Group chair / co-chair. Activities / service must be related to a practice-based competency for genetic counselors.</li> <li>0.1 PAC for at least 10 hours per year in an active service role on a committee / taskforce, Special Interest Group or with an organization. Activities / service must be related to a practice-based competency for genetic counselors.</li> <li>Max 1 PAC per year</li> </ul>	List organization and, dates of service. All activities / service must be related to a practice-based competency for genetic counselors.
<b>Teaching</b>	<ul style="list-style-type: none"> <li>0.1 PAC per hour of teaching. Must be a graduate-level course in an area related to a practice-based competency for genetic counselors.</li> <li>0.05 PAC per hour of educational outreach activity in an area related to a practice-based competency for genetic counselors.</li> <li>0.1 PAC per hour for giving a continuing education presentation (e.g., CEU or CME) in an area related to a practice-based competency for genetic counselors.</li> <li>0.5 PAC for coordinating / directing a graduate-level course related to a practice-based competency for genetic counselors.</li> <li>Max 1 PAC per year</li> </ul>	Document titles and dates of all graduate courses, educational outreach, CEU presentation or coordinating / directing a graduate level course. All activities must be related to practice-based competency for genetic counselors.
<b>Post-Graduate Education</b>	<ul style="list-style-type: none"> <li>0.1 PAC for each credit hour of graduate degree coursework related to a practice-based competency for genetic counselors.</li> <li>Max 1 PAC per year</li> </ul>	Document titles and dates of all graduate courses. All activities must be related to practice-based competency for genetic counselors.
